1. Purpose

Buxton Speedway is committed to providing a professional, safe and family-friendly environment.

All accredited media act as ambassadors of the Club and must protect its reputation.

Applies to journalists, photographers, videographers, broadcasters and digital creators.

2. Professional Standards

Act professionally at all times.

Respect riders, officials, staff and spectators.

Follow instructions from club management and officials.

Do not attend duties under the influence of alcohol or drugs.

Only access areas permitted by accreditation.

3. Safety & Accreditation

Comply with all safety instructions.

Attend briefings if required.

Display passes at all times.

Do not transfer accreditation.

Report lost passes immediately.

4. Restricted Areas

Remain in designated media areas unless authorised.

Do not enter the track or infield without permission.

Follow marshal's instructions.

Wear PPE where required.

5. Behaviour & Reputation

Avoid behaviour that brings the club into disrepute.

Do not interfere with riders or officials during competition.

6. Confidentiality & Content

Do not publish confidential club information.

Do not disclose contracts or internal matters.

Do not share embargoed content without permission.

Avoid content that harms the club's reputation.

7. Social Media

Act responsibly when posting.

Avoid speculation on internal matters.

Respect embargoes and restrictions.

8. Child Protection

Do not photograph or interview minors without consent.

9. Smoking & Conduct

No smoking or vaping in restricted areas.

Keep work areas clean.

Store equipment safely.

10. Breach of Code

• Any individual found to be acting on behalf of, or in association with, a person who is not authorised to undertake media activities at the venue may be refused or have their access withdrawn.

• Failure to sign this agreement will result in the refusal or withdrawal of press/media access to Buxton Speedway.

May result in removal from the venue.

Withdrawal of accreditation.

Suspension of access.

11. Validity of Agreement

This agreement remains valid for either:

- A single meeting (valid only for the date signed), or
- The full season (annual accreditation, unless withdrawn by the Club).

The applicable option should be confirmed by the Club or indicated on the accreditation issued.

12. Content Ownership

• All content captured at Buxton Speedway under accreditation may be used for editorial and promotional purposes only.

• Commercial use, resale, or distribution to third parties requires prior written permission from the Club.

13. Club Content Rights

• Buxton Speedway reserves the right to request copies of images and footage captured at events for club use, including social

media and promotional material.

14. Media Exclusivity

- Accredited media must not undertake media duties for other individuals, teams, or organisations at the venue without prior approval from Buxton Speedway.

15. Accreditation Status

- Media accreditation is granted at the discretion of Buxton Speedway and may be revoked at any time without notice.

16. Sign-In Requirement

- All media personnel must sign in upon arrival and collect official identification.
- Failure to do so will result in no access to restricted areas.

17. Equipment & Liability

- Buxton Speedway accepts no responsibility for loss, damage, or injury relating to personal equipment or individuals while operating at the venue.

18. Media Authorisation

All media activity at Buxton Speedway must be approved in advance by the Club.

Approval is managed by the Buxton Speedway Media Team and/or an appointed Club representative.

No individual may undertake media activities on behalf of Buxton Speedway without prior approval.
